<u>Proposed Resolution -</u> Authorizing the Chautauqua County Executive to Accept Up to 6
Laptops(or 6 Tablets) on Behalf of Chautauqua County to Aid in the
Battle Against the Opioid Epidemic

Ms. Lis: The New York State Department of Health and the CDC together have a program where they may, we are right now applying for it, provide us with up to 6 computers for our Coroners. So they will have nice new Surface Pros and it will help them do their jobs. Free of charge which is a wonderful thing and actually the computers they have now, they have some Surface Pros that are quite new and what we'll do is probably ship them over to someone else because we still have some we need to get in our Services Unit.

Chairman Wilfong: Does the software come with that?
