Dear Sister,

You were recently notified by Bro. H.P. **Perrin** of our attempt to revise the list of members in the Fredonia Baptist Church [crossed out: and that we wanted to learn your wishes, in regard to your membership.] You had been absent about nine years, and we had known very little of you during that time. With ten others, you were baptized by Rev. L. **Williams** Jr. April 26<sup>th</sup> **1874**. On the 4<sup>th</sup> of April in the Covenant meeting when you were received as candidates, our Pastor was sick, and the baptism was delayed [crossed out: to April 26<sup>th</sup>]. Do you recollect that I was appointed a committee to converse with your parents & learn if there were any objections [crossed out: to your uniting with the Baptist Church,] as you were young & your relatives were Presbyterians. I went up to your house, and talked with your mother, who consented & made no objection. Your father absent. I do not know what Bro. **Perrin** wrote to you, but have no doubt of its propriety & mildness. I commend you for replying to him, and in the apparently honest & sincere style that you did. I am an old man now, nearly 87. and I do not now attend the evening meetings in business, but do in A.M. Sundays in the Auditory. [crossed out: We had a good preacher, after Bro. **Williams** left, Rev. Malcolm **MacGregor** now in the City of New York, a Scotchman.] Our present Pastor Rev. Chas. E. **Smith** is an excellent preacher, and my wonder is, that such preaching from week to week, & year to year, should have so little effect on the people of this place.

Until last Sunday I had not seen your letter, then it was handed to me, & I was glad to read it. Some misspelling, and some wrong words used, but I could understand your meaning, & was pleased with it, in whole. You ask him to get you a letter from this Chh. as you hardly know how &c. [crossed out: Had you

written years ago, to me, (the Chh. Clerk,) you would have been replied to at once, and your request answered.]

A Baptist Church gives only a Certificate of good moral & Christian character to one who goes to any other than a Baptist Church, but to another church of our denomination, a letter of commendation and dismission, to unite. After reading your letter, more than once, I am inclined to send you what you ask for, a letter to any other Bap. Church, rather than the usual Certificate so that if you have an opportunity to join a Baptist Church wherever you may be, you can do so, but, if you decide to join a Presbyterian Chh. [crossed out: or any other evangelical Chh.] the letter will be just as good, as a Certificate for you. Were I, just in your place, I should delay some time, before uniting with any other than a regular Baptist Church. You have a kind & loving husband, (possibly not religious,) and you have lovely and interesting children, one, more than ordinary, so, responsibilities rest on you to try to guide them aright. God bless & guide you in the right way, and help you to discharge your obligations, and bring you & yours to His kingdom at last. Your friend & Bro in Christ

Dear Sir I received a letter from you which I was very glad to get.

Will say in reply I have been thinking for a long time of writing to some friend for our minister's address so as to write for a letter. We have no Baptist Church here and not likely to ever have as this is a small place of only between 3 and 4 hundred inhabitants, and 3 Churches in the place, the Catholic being the largest; then this Winter the Methodists erected a small Church and Presbyterian Church which only has service in twice a month on Sunday eve. I think I am the only Baptist in the place. I hate to with draw from them as I feel more at home with the Baptists. I have thought from year to year Mr. **Olney** would be called else where and probably we go where there was a Baptist Church so I would wait and see but we are likely to remain here for a long time as I think it best for me to unite with the Presbyterian Church here. We are expecting to have a minister here every Sunday eve after next Sabbath - Rev. **Bell**. He is young and an excellent Minister, just what we knead in the place. There are some good Christian people here but we all knead waking up. He will preach in Clayesendon in Morning and here in eve. That is about 9 miles from here.

In the 7 years that I lived here I been to Fredonia but a few times, my cares are here and it's hard for me to leave. I often think how well I liked to attend Sunday School once more there and the good old fashion prayer meetings in that little room in the basement I have never forgotten and I hope I have not been forgotten there although it is 9 years about since I have had the pleasure of meeting with you there and the dear pastor that then preached they tell me has gone to rest in his Heavenly home. Many Changes have taken place since then.

Would you please be kind enough to get a letter for me as I hardly know how and not acquainted with the Pastor or his name even. I regret that I can not be present the 5 of April to Fellowship Meeting with you but it is impossible I hope some day to meet with you all once more in that Church which I so hated to leave for there I felt at home. I have been like a wandering Jew ever since.

I have a kind and loving husband and two Children both boys, the oldest 6 years old, the youngest 4. The oldest one is [a] very religious little fellow and talks about God a great deal. He been going to Sunday school 3 years this coming June. The other eve after he finished saying his prayer he says Mama why do I say ever night "If I should die before I wake now I don't want to die before I wake up because I want to see the Angels carry my spirit to heaven. He has an old head on a little body and the Bible is a great study to him and we have taken great pains to teach him the right way. The baby has been sick a great share of his time. We have not expected to raise him but the dear God has been so kind to spare our darling. He is growing stronger as he grows older. I shall have to bring this to a close remaining

The moderator then asked Bro. **Elgar** to relate his experience to the council. Bro. **Elgar** gave an account of his conversion, call to the ministry, and views on Christian doctrine. After being questioned at length, by members of council, motion was made by Rev. Chas. E. **Smith** & carried, that council retire for consideration of candidate's statements. Council immediately met in secret session, and after due deliberation upon the matter, motion made by Newton **Crissey**, prevailed, "that this council express itself as satisfied with the candidate's Christian experience; statement of Christian doctrine, and call to the ministry."

Motion prevailed that council proceed to arrange for ordination service at 7:30 o'clock p.m.: which was as follows: - Ordination sermon, Rev. C.A. **Adams**; alternate, Rev. G.O. **King**; ordinating prayer, Rev. A. **Knight**; hand of Fellowship, Dr. F.B. **Palmer**; charge to candidate, Rev. Chas. E. **Smith**; benediction, brother Thomas **Elgar**.

Ordered a copy of minutes presented to brother Thomas **Elgar** and one retained by clerk, and the clerk instructed to prepare notice for publication in the "Examiner."
