Constitution of the Chautauque Bible Society Auxiliary to the American & Foreign Bible Society

adopted at Forestville Sept. 7th, 1837

Article 1.

This Society shall be called the "Chautauque Bible Society" auxiliary to the American Foreign Bible Society, whose single object shall be to aid in circulating the Holy Scriptures in the most faithful version that can be procured.

Article 2.

All persons contributing one Dollar or more annually shall be members of the society; and those who pay Ten Dollars at one time, shall be members for life. Life members or Life directors of the Parent Society, residing in the bounds of the Chautauque Baptist Association, shall be entitled to membership in this also.

Article 3.

Any church or society may become auxiliary to this body by paying annually into the Treasury, after their own incidental expenses are deducted, their surplus funds, and forwarding to the corresponding secretary a list of their officers and such others as they deem expedient. Such members of auxiliary societies as subscribe one dollar annually, shall be entitled to membership in this body, and those who subscribe Ten Dollars to their funds at one time shall be entitled to life membership in their society. Auxiliary societies shall be allowed the privilege of constituting one Life Member of this Society for each Ten Dollars paid into the treasury. Life membership or life directorship of the Parent Society will be guaranteed to such individuals as wish the privilege, or are nominated by auxiliaries by the payment into the treasury of the sum required by the constitution of the Parent Society.

Article 4.

The funds of the society, after deducting incidental expenses, shall be paid over to the Treasurer of the American & Foreign Bible Society, to assist in supplying the destitute with the word of truth.

Article 5.

The Society shall elect, annually, a President, Vice President, a Corresponding Secretary, a Treasurer and Ten Directors. The last twelve persons shall be members in good standing in Baptist Churches & shall constitute an executive committee – and in case of failure of an annual election the whole board shall hold their offices until a new election is made – all officers of the Society or of auxiliaries, and life members, and Ministers of the gospel who are members of the society, shall be entitled to a seat in the meetings of the executive committee when present.

Article 6.

The President, or in his absence, one of the Vice Presidents shall preside at the meetings of the society.

The Secretary shall conduct the correspondence of the society & of the Executive Committee, shall notify all meetings of the Society & of the Executive Committee, arrange the business to be brought before them, keep a record of their doings, and notify the persons chosen officers at the annual meeting, of their appointment. The Treasurer shall receive all monies collected & hold them subject to the direction of the Executive Committee, and shall make a report at the annual meetings of the Society. The Executive Committee, a majority of whom shall be a quorum shall meet from time to time to manage the business of the society. – They shall direct the Treasurer in the appropriations of all moneys, make arrangements for the annual meetings of the society, cause a report of their proceedings to be prepared for the annual meetings, and a copy of the same with a list of the officers to be transmitted to the Parent Society, and make such appointments and adopt such measures as are best calculated to promote the interests of the Society. They shall enact their own by-laws, and fill such vacancies as may occur in their own body.

Article 7.

There shall be an annual meeting of the Society on the 4^{th} Wednesday in Feby. when the accounts of the Treasurer shall be presented – the annual report read – officers chosen & such other business transacted as the interests of the Society may require.

Article 8.

No alteration shall be made to this Constitution, except by the Society at an annual meeting.

The first annual meeting of the Chautauque Bible Society, was held agreeable to adjournment at the Baptist Meeting house in Mayville Feby. 7th, 1838.

The meeting was called to order at two o'clk. P.M. by the President, Rev. W. Winsor.

Prayer by the President.

Delegates from auxiliary societies and Churches invited to a seat.

A delegation from the following Churches & Societies appeared & took their seats. – viz – 1^{st} Pomfret – Mayville – 2^{nd} Hanover – Portland – Sherman – 1^{st} Stockton – 2^{nd} Stockton – Harmony – Clymer – Dunkirk – Westfield – Silver Creek – Cassadaga – LaGrange – Ellory - & Dewittville.

Heard the Constitution of the Society.

Appointed a committee to divide the association into districts, so as to have the claims of this Society presented before the different churches and especially, feeble & remote churches, who have limited means for information.

The above committee consisted of Rev. W. Winsor, J. G. Brown, O. Dodge, E. R. Swain & D. Woodbury.

Proceeded to elect officers for this ensuing year as follows: President -Rev. Washington Winsor Vice Presidents -Rev. J. G. Brown Rev. P. Cross Rev. A. Chapin Rev. J. Schofield Rev. Geo. Witherell Rev. E. R. Swain Rev. J. W. Nye Brn. N. Crosby, J. Crissey & S. Eaton. David Barrell, Secretary; Josiah More, Treasurer Directors -Rev. W. T. Boynton, O. Dodge, H. B. Ewel, Brn. Wm. Sexton, Jesse Brooks, A. S. Moss, J. Arnold Brn. L. Cottrell, D. Y. Powers & A. A. Atherly.

Resolved that the next annual meeting be held with the 2nd Church of Stockton, 4 Wednesday, Feby, 1839 & that Rev.'d S. Little, W. Winsor & Bro. S. Crissey be a committee to make arrangements for the next annual meeting.

Adjourned to ¹/₂ past 6 this evening.

Met agreeable to adjournment – Hymn of praise from the Choir – Prayer by Bro. Nye.

The following resolution presented & sustained by Bro. J. G. **Brown** & seconded by Bro. **Nye** was adopted.

Resolved that to aid in the effort to give bible to the Whole family of Man, is a duty we owe to God & to our fellow creatures.

The following resolution presented & sustained by Bro. W. T. **Boynton**, seconded by Bro. H. B. **Ewel** was adopted.

Resolved that a distinct organization of the Baptist denomination for the purpose of aiding in the translation, printing & distribution of the Holy Scriptures throughout the world was urgently demanded, & that we greet the American & Foreign Bible Society as an organization eminently calculated to meet that demand.

The following resolution presented & sustained by Bro. B. N. Leach, seconded by Bro. D. Barrell was adopted.

After deliberation it was resolved that we view it duty to employ <u>an agent</u>, to visit the churches in the bounds of this society, who may be the instrument, under God, of awakening the churches to their duty to this society & diffuse light on the subject.

Resolved that Bro. J. Schofield be invited to enter the field as our agent.

Heard remarks from Eld. **Schofield** signifying his partial assent, if the church with whom he labors consent.

Resolved that we desire Eld. **Schofield** to spend 3 months in the employ of the Society, before our next annual meeting.

Resolved That Eld. **Schofield** receive One Hundred dollars from the funds of the Society as his salary for 3 months.

Resolved that Eld. **Schofield**, Brn. **More & Barrell** be a committee to obtain or publish an address or circular to scatter among the Churches, & that the expense be defrayed at the annual meeting.

Closed by Prayer. David **Barrell**, Secty.

The Chautauque Bible Society Auxiliary to the A. F. B. S. held their 3rd anniversary agreeable to adjournment at the Baptist meeting house in Forestville 26th, Feby., 1840.

Introductory Sermon by Bro. Chapin of Jamestown, founded on Luke $11^{th} - 28^{th} v$.

Resolved that it is both the duty & privilege of the denomination we represent, to sustain this glorious enterprise, both by their prayers and their alms. Passed.

Resolved that in view of the blessings of Heaven bestowed on this Society the past year, we have occasion to thank God and take courage. Passed unanimously.

Resolved that we so amend the constitution as to correspond with the alteration in the time of holding annual meeting,

The Eleventh Annual meeting of the Chautauque Bible Society held at Ellory February 16th, 1848 at 10 ½ o'clk. A.M. after a session of prayer the President, Rev.'d M. **Purinton** called the Society to order, and in the absence of the Secretary, requested the Treasurer (by whom the records had been forwarded) to read the names of officers of Society.

1st Resolved to invite Rev.'d Gibbon **Williams**, agent of the Am. & For. Bible So., who was present, to address the So. & Congregation this morning.

2. Resolved that A. Z. Madison be appointed Secretary Pro tem.

3. Rev.'d G. **Williams** offered remarks on the subject of Book Depositories & Home distribution.

Sung two verses of Missionary Hymn.

Prayer by Rev.'d N. Thomas.

Rev.'d G. **Williams** again resumed remarks on the subject of Foreign distribution, with a brief history of efforts for the diffusion of the Bible from the days of Carey **Thomas** etc. Elder **Williams** closed with the remark that under the circumstances he would not ask brethren for contributions, but while some following business was being transacted, Elder F. **Kidder** passed the hat & rec.'d contributions amounting to \$4.56.

10. Resolved to adopt the report entire. The past President called the first Vice President Elect Viz. Rev. F. **Kidder** to the chair.

11. Heard the report of the Treasurer as relates to funds now paid in the Amt. \$54.63.

12. Resolved that with \$30 of this money there be a life member of the Am. & For. Bible So. appointed.

13. Resolved that Rev. Alfred **Handy** be named as such life member.

{Here a proposition was made that some brother should make himself a life member of A. & F. B. So. by contributing \$5.37 to the balance of funds \$24.63 which, at length resulted in the contribution of the sum \$5.37 to make up the \$30. for the purpose of appointing their Pastor Rev. J. J. **Fuller** Such life member, by the Ellery church.}

14. The auditing Committee (Rev. A. **Handy** & D. **Morse**) after having examined the account & vouchers of the Treasurer, Reported it as being correct.

15. Resolved to accept & adopt their Report.

16. Resolved that with the \$30 now paid in, (Ellery ch. having contributed \$5.37 for this object) Rev. J. J. **Fuller** be appointed a life member of the Am. & For. Bible So.

{Here Rev. A. **Handy** with appropriate and affecting remarks in allusion to our venerable brother Dea. S. **Higby**, proposed to resign the privilege and honor of being himself appointed a life member of Am. & For. Bible So. in favor of Dea. S. **Higby**.

Several remarks were made by brothers on this subject, which closed by Dea. **Higby**'s expression of thanks to Elder **Handy**, desiring him retain the appointment made by the Society, as the privilege and benefit would probably be greater to one in the prime office, than to himself, aged and nearly worn out, and fast hastening to his final account, as he was.}

17. Resolved that the several speakers on Resolutions to be offered, be limited in time to 15 minutes each.

18. Resolved that the Treasurer pay over money now rec.'d by him in contributions & from book depositaries to Rev. Gibbon **Williams** Agent of The Am. & For. Bible Society, present.

19. Rev. A. **Handy** introduced & with arguments moved the following Resolution to wit. "Since <u>God's truth</u> is the Heaven-appointed instrument in Evangelizing the world, Therefore,

20. Resolved that the Am. & For. Bible So. is worthy of our confidence & Support for its <u>fidelity</u> in giving to the world <u>faithfully translated</u> versions of the Sacred Scriptures." The foregoing Resolution was seconded with remarks by Rev. F. **Kidder** & adopted.

Rev. D. Morse moved the following,

21. Viz. "Resolved that the lamentable destitution of the Sacred Scriptures which prevails in many parts of our own country and the facilities for supplying the destitute, loudly call upon us to aid the Am. & For. Bible So. in the work of home distribution." Seconded by Rev. S. **Rathbun** with remarks by himself, Rev. A. **Handy**, Rev. G. **Williams** and A. Z. **Madison** & adopted

Rev. J. C. Stoddard moved the following,

22. Viz. "Resolved that the numerous and thrilling appeals, from Foreign lands, for the Sacred Scriptures, furnish strong inducements to aid the Am. & For. Bible Society in the work of Foreign distribution." Seconded with remarks by Rev. J. M. **Purinton,** and adopted.

Rev. G. **Williams** offered the two following Resolutions which were seconded and adopted.

23. Viz. Resolved that each Pastor connected with this Society be allowed to take five dollars worth of Bibles out of the Depository, for which they shall be accountable, having the privilege to return those not sold once in 3 months.

24. Resolved that Bro. David **Barrell** be requested to order a sufficient quantity of Bibles & testaments to supply our demand.

25. Resolved that when this Society adjourn, it adjourn to meet with the ch. in Mayville on the 3^{rd} Wednesday of Feb. next at $10\frac{1}{2}$ o'clock A.M. according to constitution & amendment.

26. Resolved to adjourn.

- 14. Resolved that the present state of Continental Europe The vast fields open to the circulation of the scriptures among the adherents of the man of sin and the advocates of other systems but little in advance of that demand of us the most faithful and self sacrificing efforts.

This Resolution was moved by Br. **Rathbun** and seconded by Br. Herman **Minger** Agent of the Parent Society and passed.

15. Resolved that the cause of Foreign Mission promises success only as it has the means to print & circulate the Holy Scriptures fully translated into the Languages of the natives & we ought therefore to our utmost to sustain the A. & F. B. Society in prosecuting their Foreign work.

This Resolution was moved by Br. S. S. Ainsworth seconded by Br. F. Kidder and passed.

16. The Society adjourned to hold its next session at the usual time in Fredonia.

- 14. Resolved, That We tender our hearty thanks to our Depositories Viz. J. B. **Burrows** and D. **Barrell**, for the faithful and judicious manner in which they have performed their service.
