Legislator Nelson: Just a quick comment, Mr. Chairman. As one of the Jamestown legislators, I just want to wholeheartedly support this resolution. I think it's a much needed improvement to the CARTS Hub in the City of Jamestown and it's greatly appreciated.

Legislator Parker: Thank you Chairman Chagnon. I wanted to note that there are three different items that are being asked for on January 24th, in preparation of April 8th and one of them is medical supplies which I think is needed. The other one is software and location awareness, I mean that's not the right word but anyway and then the third thing is these two large signs. My understanding is that it may be difficult to get these signs. They are not absolutely in my opinion, necessary we have two already and I had asked for a compromise. This close to \$200,000 in unassigned fund balance, is 20% of the million dollars we asked to be given back to the residents of Chautauqua County and so I cannot support this, thank you.

Legislator Niebel: Thank you, Mr. Chairman. This resolution takes money from the unassigned fund balance, money that comes primarily from local property taxes and look, we have a lot of middle class taxpayers that I think are struggling to make ends meet. Past Legislatures were very reluctant to take money from the from the fund balance, especially if we had an alternative funding source and in this case we do, the 3% Tourism Reserve Fund, a dedicated fund paid for by tourist staying in hotels and motels in Chautauqua County. It's our bed tax. This is where the money should come from and when the time is appropriate Mr. Chairman, I'd like to make a motion to amend this resolution.

Legislator Wilfong: Thank you, Mr. Chairman. I had an opportunity to caucus with my group before we came in and there were some questions that came up and luckily, I spoke to

Noel Guttman out in the hallway and he believes that these supplies that he's asking for, for Emergency Services are absolutely necessary. During the Audit and Control meeting that we sat in last week, Mr. Chagnon himself actually read the actual legal ramifications of the 3% Occupancy Tax. In consulting with our higher officials in the State, they said don't even try to get that money out of there. If you want this, it's going to have to come out of the general fund so I believe that we should recognize Noel Guttman for his expertise and what he needs and that we should give him what he's asking for because what happens if we do have a problem? Hopefully we will not but it's very important that we actually take pride in County and make sure everybody is safe, thank you.

Legislator Nelson: Thank you, Mr. Chairman. As a member of the Public Safety Committee, I oppose this resolution. I feel that the eclipse will be a significant event. We'll see a bump in tourism, we will see additional traffic in the County but I don't think it warrants this additional spending. I have confidence that we will be prepared for the day and that the safety of the County residents will not be compromised without spending an additional \$200,000 from our unassigned fund balance, thank you.

Legislator Niebel: I think Noel's request is reasonable okay, my concern is the funding source that we take this money out of. I'd just like to go back to the County website. The application process for 2024, 3% tourism projects, I printed this out this afternoon but I'm not going to read the whole thing but just this one sentence, "programs and initiatives should help create awareness of Chautauqua County as a place to visit and or improve the likelihood of repeat visits to this area". It's my contention that if people come here for the eclipse, that they have a safe and pleasurable experience. I think there is a good chance that they're going to come back in the future so I feel that it would be proper to take this money from the 3% tourism reserve fund.

MOVED by Legislator Niebel, SECONDED by Legislator Scudder to use funding from the 3% Occupancy Tax instead of the Unassigned Fund Balance

Chairman Chagnon: So we have a motion and a second to amend the resolution as Legislator Niebel just indicated. Discussion on the motion to amend? Hearing none, all those in favor of amending resolution 25-24 as indicated by Legislator Niebel, please say "aye". Opposed? Would the clerk please call the roll?

Chairman Chagnon: Okay, so motion to amend the resolution is defeated. Is there any other questions, comments or discussion on resolution 25-24 as presented?

Legislator Penhollow: Mr. Chairman, I would ask that Noel Guttman – how confident we are that there could be other grants out there to backfill this usage from the unassigned fund balance? That's just a question that could be noted.

Legislator Wilfong: I just want to say when Noel spoke with us, one of the reasons that it's written the way it is, the 2024 Eclipse Preparedness is just in case later on, the State or Federal Government make funds available, we can actually apply for those and then reimburse ourselves so that's why its amended and the title is the 2024 Eclipse Preparedness so we could slip in, if there is any, but we're not guaranteeing that there is.

Legislator Niebel: Thank you, Mr. Chairman. If Emergency Services says this equipment is necessary for the eclipse, I will support it. My concern is where the funding came from and well, I guess it has to come from the unassigned fund balance, so I will support a motion now as written.
