Legislator Wilfong: I just want to welcome everybody to the City of Jamestown on February 3rd. Its Doors Open Jamestown, where a lot of those places will be open for free, the Comedy Center, the Fenton Historical Society will be there, the Lucy Desi stuff will all be free so have people come down and enjoy that opportunity. That's February 3rd.

2nd Privilege of the Floor

Chairman Chagnon: I will open 2nd privilege of the floor where members of the public may comment on any subject. A member of the Legislature may speak on any subject. Individual comments are limited to 3 minutes and comments representing a group shall be limited to 5 minutes.

Good Afternoon. Congratulations to each of you for winning seats to the 2024 Legislature. I am John (inaudible) of 213 Spruce Street, Lakewood New York representing myself today. I am here today to speak about the need for each of us in this room to take action to reduce the pollution causing global warming and ocean acidification. The 2023 year was the hottest year on record across the globe. Chautauqua Lake didn't completely freeze last year. We suffered from days of climate change, driven heavy smoke from Canadian wild fires that impacted our health and our outdoor activities in Chautauqua County. Our businesses are being harmed by ever shorter snowmobiling, skiing, cross country skiing, snow shoeing and ice fishing seasons. Our farmer's livelihoods are endangered as our fruit (inaudible) our vineyards and orchards are threatened by erratic early season excess warm followed by later frost. Greenhouse gas pollution in the form of carbon dioxide methane is drastically changing our climate and weather. We can't escape these impacts in Western New York. As we humans have until 2030 to cut our consumption of fossil fuels, and our production of methane by at least 50%, we must take action now. I ask each of you in this room to accept the reality that we need to take effective actions now to substantially conserve energy to reduce energy usage. The development and consumption of all forms of energy have (inaudible) impacts on our environment. I ask you to strongly support programs and make opportunities available in Chautauqua County for cutting use of fossil fuels in our homes, vehicles, businesses and industries. You may feel it is inconvenient and not necessary to make these changes but a little inconvenience now in the next

5 to 10 years to better conserve energy and switch away from fossil fuels is sure better than the deadly consequences of letting the fossil fuel consumption status (inaudible) continue. I ask you to get on board with effective actions to reduce carbon dioxide and methane pollution now for the sake of your children and grandchildren and all of us to follow. Our generations must act now. We can't put it off any long. We've got to do this by 2030, we've got to get this done. Thank you for your time and for your service on the Legislature.
