South Chautauqua Lake Sewer District Lateral Restrictions for Agricultural District Properties Situated within the District Phase 2 Boundary Extension

At the Request of Legislature Chairman Pierre E. Chagnon:

WHEREAS, pursuant to Resolution 162-22 the County Legislature approved the extension of the South Chautauqua Lake Sewer District (District) boundary from the Hamlet of Stow to the south bounds of the North Chautauqua Lake Sewer District on the West Side of Chautauqua Lake, referred to as SCLSD Extension Phase 2; and

WHEREAS, the SCLSD Extension Phase 2 is subject to regulatory requirements, including those of the New York State Department of Agriculture and Markets; and

WHEREAS, the Department of Agriculture and Markets has requested that the District impose lateral restrictions for properties within the SCLSD Extension Phase 2 area that are encompassed in an Agricultural District; and

WHEREAS, all properties within the SCLSD Extension Phase 2 area that are situated within an Agricultural District are located along New York Route 394 and Davis Road, as shown in the maps included with this Resolution; and

WHEREAS, at its April 11, 2024 meeting, the South and Center Chautauqua Lake Sewer District Board voted in favor of lateral restrictions as reflected herein; now, therefore, be it

RESOLVED, That the following Notice of Intent concerning Lateral Restrictions be adopted:

NOTICE OF INTENT CONCERNING LATERAL RESTRICTIONS: CONDITIONS ON FUTURE SERVICE

The South Chautauqua Lake Sewer District imposes the following conditions on the management of sewer lines located along New York Route 394 and Davis Road within an agricultural district, maps of which are attached to this resolution showing the boundaries of the agricultural district in relation to the parcels indicated:

(1) The only land and/or structures which will be allowed to connect to the proposed sewer within an agricultural district will be existing structures at the time of construction, future agricultural structures, and land and structures that have already been approved for development by the local governing body prior to the date of filing of this Notice of Intent (NOI) by the County.

Land and structures that have been approved for development refer to those properties/structures that have been brought before a local governing body where approval (e.g., subdivision, site plan, special permit) is needed to move forward with project plans and the governing body has approved the action. If no local approval is required for the subdivision of land and/or the construction of structures, the County accepts the limitation

under Public Health Law §1115 that defines a "subdivision," in part, as "any tract of land which is divided into five or more parcels." Sewer service will not be provided to more than a total of four residences, buildings and/or structures on any tract of land which has been divided into parcels after the date of filing of the NOI by the municipality, where no local approval is required and the land is located within a county adopted, State certified agricultural district.

- (2) If a significant hardship can be shown by an existing resident, the lateral restriction to the resident's property may be removed by the County upon approval by the Department. It is the responsibility of the resident landowner to demonstrate that a hardship exists relative to his or her existing septic system and clearly demonstrate the need for public sewer service. The County shall develop a hardship application to be filed with the County, approved by the County Department of Health, and agreed to by the Department of Agriculture and Markets.
- (3) If it can be demonstrated to the Department's satisfaction that the landowner requested the County to remove his or her land from an agricultural district at the time of district review and the County legislative body refused to do so, lateral restrictions may be removed by the County if the Department determines that the removal of the restriction for the subject parcel(s) would not have an unreasonably adverse effect on the agricultural district.
- (4) If land is removed from a County-adopted, State certified agricultural district and the district has been reviewed by the County legislative body and certified by the Commissioner for modification, lateral restrictions imposed by the County are no longer in effect for the parcels of land that have been removed from the agricultural district.

At the Request of Legislative Chairman Pierre E. Chagnon:

WHEREAS, the North Chautauqua County Water District (District) is interested in making improvements to the water system that will enhance the system reliability and redundancy; and

WHEREAS, the proposed Phase 3 project will include:

The replacement of up to 6,300 linear feet of the existing 6-inch water main along NYS Route 5 in the Town of Portland between the Village of Brocton and the Town of Pomfret. The existing water main is undersized, and the replacement will enable the supply of water to the Town of Pomfret. The new 12-inch water main will also enhance the redundancy of the system by permitting flow from the Town of Pomfret under emergency conditions.

The installation of approximately 2,100 linear feet of new 8-inch water along Williams Street between South Roberts Road and Bennett Road. The new main will provide a critical interconnection in the system, allowing water to flow between the existing services areas should their regular supplies be interrupted.

The installation of approximately 3,500 linear feet of 12-inch water main along Bennett Road in the Towns of Pomfret and Dunkirk. The new main will provide a critical and redundant connection between the Town of Pomfret and Dunkirk systems, which currently only have a single source of supply.

The replacement of up to 4,500 linear feet of the existing 8-inch water main along NYS Route 5 in the Town of Dunkirk between the City of Dunkirk and the Town of Sheridan. The existing water main is undersized, and the new 12-inch water main will also enhance the redundancy of the system.

The installation of approximately 6,600 linear feet of new 12-inch water along NYS Route 5 in the Town of Portland. The new main will provide an interconnection with the supply from the Village of Westfield, allowing for emergency supply between the systems.

New master meter pits will be installed at all municipal boundaries and at the boundary of the North County Industrial Water District. The master meters will be used for billing purposes, allowing the NCCWD to bill the participating municipalities directly. The new master meter will also enhance the ability to track and identify water losses in the system; and

WHEREAS, in accordance with the provisions of 6 NYCRR Part 617 (SEQRA), the County intends to serve as Lead Agency for SEQRA review of this Type 1 Action and will determine if the proposed action will have a significant affect on the environment; and

WHEREAS, the Lead Agency will undertake a coordinated review of this proposed action, and now therefore be it,

RESOLVED, That the County hereby designates its intention to serve as Lead Agency for the proposed action and will circulate Lead Agency Notice along with Part 1 of the Long Form Environmental Assessment Form and any other supporting documentation to all Involved Agencies. These agencies shall be given 30 days from the mailing of the Lead Agency Notice to consent. Interested Agencies will be given notice, but not required to consent pursuant to 6 NYCRR Part 617.6.

Authorizing Public Hearing Regarding Third Modification to Map and Plan for Improvements in the North Chautauqua County Water District

At the Request of Legislative Chairman Pierre E. Chagnon:

WHEREAS, pursuant to General Municipal Law Article 5-C including §118, any County on behalf of a county water district may, in addition to all other powers possessed with respect to the development and distribution of water, provide for the development of a supply of water in excess of its own needs for the purpose of sale to a public corporation or improvement district, and any provision of law to the contrary notwithstanding, may contract indebtedness for such purpose; and

WHEREAS, pursuant to Resolutions 260-15, 39-16, and 81-16, the Chautauqua County Legislature established the North Chautauqua County Water District (the "District"), to comprise an area in Chautauqua County consisting of parts of the towns of Portland, Pomfret, Sheridan and Hanover and all of the town of Dunkirk, and authorized bonding in a maximum amount of \$11,750,000 for the cost of the initial capital improvements for the District; and

WHEREAS, subsequent to the adoption of Resolutions 260-15, 39-16 and 81-16, the County Legislature on August 23, 2017 adopted Resolution 231-17 to modify the initial capital improvements due to changes in the structure of the financial assistance to be received from New York State's funding agencies, and changes in the timing of projects to be completed in the District's development; and

WHEREAS, as of January 2019, the District found it again necessary to modify the initial capital improvements as previously modified in August 2017, which is due to further changes in Page 13 of 19

the structure of the financial assistance to be received from New York State's funding agencies, and additional changes in the timing of projects to be completed in the District's development; and

WHEREAS, as of April 2024, the District has found it again necessary to modify the initial capital improvements as previously modified to add municipal master meters as originally contemplated by paragraph 7 of Agreement 16-01-02 titled "Water Purchase / Supply Agreement," and to enable increased flows, emergency water supplies and redundancy; and

WHEREAS, the Chautauqua County Legislature has received from the District Board a modified Map and Plan entitled "North Chautauqua County Regional Water System Map and Plan-Amendment #3" dated April 2024 (hereinafter referred to as the "Map and Plan") prepared by engineers at Clark Patterson Lee (CPL) that are duly licensed by the State of New York, with the request by the District Board that this Legislature call a public hearing thereon consistent with County Law § 253-b and § 254; now therefore be it

RESOLVED, That a public hearing will be held by the Chautauqua County Legislature at the Legislative Chambers, Gerace Office Building in the Village of Mayville, Chautauqua County, New York on May 22, 2024 at 6:35 o'clock PM, prevailing time, on the question of the adoption of Map and Plan Amendment #3 that includes changes to the improvements, and to take such action thereon as is required or authorized by law; and be it further

RESOLVED, That the Clerk of the Legislature is hereby authorized and directed to cause a copy of the Notice of Public Hearing hereinafter provided to be published once in the official newspapers of the County and to be transmitted by first class mail to each purchaser of District water using the address in the contract between District and the purchaser or such other address as has been provided by such purchaser, not less than ten (10) nor more than twenty (20) days before the date designated for the hearing; and be it further

RESOLVED, That the Notice of Public Hearing shall be in substantially the following form:

Notice is hereby given that the County Legislature of the County of Chautauqua, New York, will meet in the Legislative Chambers, Gerace Office Building, Mayville, New York on May 22, 2024 at 6:35 o'clock PM, prevailing time, for the purpose of conducting a public hearing on the question of the adoption of the third modified Map and Plan for the construction of improvements for the North Chautauqua County Water District in said county that modifies the Map and Plan previously approved by the Chautauqua County Legislature on December 16, 2015, which was first modified on August 23, 2017 and subsequently modified pursuant to Resolution 82-19 adopted on March 27, 2019, such third modification being posted here: and generally consisting of:

- (1) the replacement of up to 6,300 linear feet of existing 6-inch water main with 12-inch water main, along NYS Route 5 in the Town of Portland between the Village of Brocton and the Town of Pomfret:
- (2) installation of approximately 2,100 linear feet of new 8-inch water main along Williams Street between South Roberts Road and Bennett Road;
- (3) installation of approximately 3,500 linear feet of 12-inch water main along Bennett Road in the Towns of Pomfret and Dunkirk;

- (4) replacement of up to 4,500 linear feet of existing 8-inch water main with 12-inch water main, along NYS Route5 in the Town of Dunkirk between the City of Dunkirk and the Town of Sheridan;
- (5) installation of approximately 6,600 linear feet of new 12-inch water main along NYS Route 5 in the Town of Portland; and
- (6) installation of new master meter pits at municipal boundaries and at the boundary of the North County Industrial Water District No. 1.

The estimated maximum cost of the improvements as modified would increase from \$19,399,500 to \$27,599,500, and the estimated annual District debt service payment would increase from \$395,050 to \$562,394. All District costs are anticipated to be paid by municipalities receiving water from the District under contract, with no assessments by the District upon properties within the District. The estimated cost to the typical property from assessments or other charges to be made by the District upon such properties is zero. Any costs of the improvement not paid by such municipalities will be assessed as nearly as may be to the benefit which each lot or parcel will derive therefrom. At such public hearing, the Chautauqua County Legislature will hear all persons interested in the subject matter thereof.
